## **ORDINANCE NO. 2022.299**

## AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF ELY, IOWA. BY AMENDING PROVISIONS PERTAINING TO COLLECTION FEES

**BE IT ENACTED** by the City Council of the City of Ely, Iowa:

**SECTION 1. MODIFIED.** Section 106.08 of the Code of Ordinances of the City of Ely, Iowa, is repealed and the following adopted in lieu thereof:

**106.08 COLLECTION FEES.** The collection and disposal of solid waste as provided by this chapter are declared to be beneficial to the property served or eligible to be served and there shall be levied and collected fees for the same, in accordance with the following. In addition, the City finds that the availability of a yard waste site is beneficial to the residents and businesses of the City and there shall be levied and collected a fee to provide for maintenance of the site and handling of the yard waste deposited at the site by residents and businesses of the City, as follows:

- 1. Schedule of Fees. The fees for solid waste collection and disposal service and the availability of a yard waste site, used or available, are as follows:
  - A. Light Generation. Each residential unit that is provided one 64-gallon residential waste cart and one 64-gallon recyclable waste cart.

2. Payment of Bills. All fees are due and payable under the same terms and conditions provided for payment of a combined service account as contained in Section 92.04 of this Code of Ordinances. Solid waste collection service may be discontinued in accordance with the provisions contained in Section 92.05 if the combined service account becomes delinquent, and the provisions contained in Section 92.08 relating to lien notices shall also apply in the event of a delinquent account.

Section 2. That all ordinances or parts of ordinances in conflict herewith are hereby repealed and this Ordinance shall be in full force and effect from and after its passage and publication as provided by law.
