1. First Reading of an Ordinance Amending Council Compensation

Presenting for council consideration is the first reading of an ordinance amending the compensation for the City Council members for the City of Ely. This change will move council members to salaried positions with a total annual compensation of \$2,400.00, paid quarterly. Council members are required to maintain no less than 70% attendance of council meetings during the quarter in-order to be compensated. This change would take effect January 1<sup>st</sup>, 2022 for all council members.

2. First Reading of an Ordinance Amending Mayor Compensation

Presenting for council consideration is the first reading of an ordinance amending the compensation for the Mayor for the City of Ely. This change would increase the Mayors total annual compensation from \$4,000.00 to 6,000.00, paid quarterly. The Mayor would be required to maintain no less than 70% attendance of council meetings during the quarter in-order to be compensated. This change would take effect January 1<sup>st</sup>, 2024 for the Mayor.
