Resolution 2021-3.007 approving Max Levy Hearing Presented for city councils' consideration is a resolution approving the Max Levy Hearing. The max levy hearing was conducted on February 15th, 2021. The following resolution is required to document the hearing being conducted.

Resolution 3021-3.008 approving extension of the Preliminary Plat for Deer Valley 4th Addition Presented for city councils' consideration is a resolution approving the extension of the preliminary plat for the Deer Valley 4th Addition. The current preliminary plat expires on March 9th. The extension has been requested by the developer. No changes or alterations have been made to the preliminary plat and there have been no changes to city code or other regulations that would require changes to be made. Motion by Wery, 2nd by Whitaker to approve extension of Preliminary Plat for Deer Valley 4th Addition. By roll call Wery, Symonds, Whitaker and Tuthill. All Ayes-4 motion carried.

Request to approve no comment on Karnowski and Tomash land splits within the 2-mile radius. A division of land is requested within the 2-mile fringe area around the City of Ely. The purpose of the land split is for preservation. The City of Ely has no approval or denial ability on this matter but can comment. Planning and Zoning reviewed this item at its February 8th meeting and had no comment. Motion by Symonds, 2nd by Tuthill to approve with no comment for land split within the 2-mile radius of the City of Ely. All Ayes-4 motion carried.

Presentation/discussion from Alliant Energy related to Electric Vehicles and EV charging

stations. The City of Ely is working to submit a grant to Iowa Department of Transportation for an Electric Vehicle charging station to be placed in Ely Downtown area. Prior to submitting the grant on March 5th, Alliant Energy shared some information on the benefits of Electric Vehicles with council.

Rob Wozny with Alliant Energy gave presentation on Electric Vehicles the EV charging stations. **Discussion on construction managers services for public works facility expansion.** Staff is still gathering information to present to council. Staff recommends bring this item up for discussion again at the March 15th meeting.
