Business-Resolution 2021-05.023 approving employee health insurance renewal was presented for City Council's consideration a resolution approving the employee health insurance policy with Trustmark Small Business Benefits. The policy provides a \$0 deductible, and maximum out-of-pocket expense of \$3,000/\$6,000 for single and family, respectively. The policy is a non-PPO plan than pays a percentage based off Medicare rates. It is also in our contract the any amount not covered by the base coverage will be handled and paid for by the insurance company. This insurance policy has been reviewed and vetted by Dean Zelle and his staff. The City of Ely can provide a better insurance plan with better benefits at a lower cost to the employee and to the City. Motion by Whitaker 2nd by Hale. Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion passed as submitted.

Resolution 2021-05.024 approving emergency purchase during Derecho emergency response was presented for City Council's consideration a resolution approving the emergency purchase of rental equipment from JDM (\$5,750) and contracting with JDM to assist with storm cleanup (\$15,080). Under our purchasing policy the City Administrator is allowed to make emergency purchases but need to get approval from council after the purchase is made. Council was informed of our recovery purchases, but no official approval was given. This approval is necessary for FEMA assistance. Motion by Hale 2nd by Wery. Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion passed as submitted.

Resolution 2021-05.025 approving write-off of bad debt was presented for City Council's consideration a resolution approving the write-off of bad debt in the amount of \$1,652.62. Periodically the City acts to write-off uncollected payments. The payments are uncollected because the City did not have a forwarding address and/or a SSN for the residents. We continue to make improvements to our process but sometimes residents are still able to slip through. Writing-off the debt will always the city to balance accounts before the end of the fiscal year. Motion Hale 2nd by Wery. Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion passed as submitted.

Resolution 2021-05.026 amending City Hall hours of operation from 7am – 3pm Monday – Friday and 7am-7pm on the first Monday of each month was presented for City Council's consideration a resolution approving the change of City Hall. Open Hours to 7am-3pm Monday-Friday and 7am-7pm on the first Monday of each month. Staff believes this change will allow for better service for the community by allowing those who commute for work and opportunity to stop in early and by allowing a late night gives an opportunity for those who only have evening available. Residents can still make appointments. to meet with staff from 7am-5pm and full-time staff will continue to work 40 hr. per week. Motion by Tuthill 2nd by Wery. Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion passed as submitted. **Request** to open City Hall to the public beginning June 1st, 2021 was presented for City Council's consideration is a request to open City Hall to the public beginning on June 1st, 2021. Staff believes the time has come that City Hall for the time being. Motion by Wery 2nd by Whitaker to reopen City Hall June 1st. Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion passed as submitted.

Discussion and potential action related to a request by a resident to remove a dying tree in the right-ofway. A request was made by the resident of 1475 Walker street to have the City of Ely remove a dying tree from the right-of-way in front of their property. City Code does not require the City to remove dead Ely City Council

or dying trees from the right-of-way. Staff talked with previous officials and staff and could not determine why right-of-way trees would have been removed over 10 years ago. It is not the cities current practice to remove trees from the right-of-way at the cities expense. Furthermore, it is staff's recommendation not to remove the tree at the cities expense. Motion by Tuthill 2nd by Whitaker not to remove right-of-way tree, it is homeowner responsibility to remove and assume costs. Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion passed as submitted.

Discussion and potential contract extension with Waste Management. Waste Management is offering an extension of our current contract for one year or a 5-year extension with a 3.5% increase in years 2-5 or a set rate at \$18.33 per unit. Our current annual increase is 3%. Waste Management is incurring increased costs, and this is the reason for the increase to 3.5%. Staff recommends a 5-year extension of our current agreement. Motion by Hale 2nd by Wery. General Discussion and short presentation by Dave Schaab of Waste Management. Motion by Whitaker to amend initial motion to extend the current contract with one time 3.5% increase year one and flat fixed rate of \$18.33 for years 2-5 and 2nd by Hale Roll Call Wery, Tuthill, Hale, Whitaker. 4-Ayes Motion Passed as submitted.

Discussion on American Rescue Plan Funding. Ely designated amount of approximately \$325,000; half to be received this FY21 and other next FY22. We have 5 years to use it. Can be used for restricted specific uses. Staff recommendation is for water and sewer infrastructure. Welcoming any other ideas or add to wish list.

With no further business being evident, council adjourned the meeting at 8:11 pm. Motion by Hale, 2nd by Wery. 4-All Ayes motion carried.
