Council Proceedings July 10, 2017

The Ely City Council met in regular session on 7/10/17 in Council Chambers. Officials present were Council Members Teri Billick, Stephanie Mehmen, Elizabeth Rohner and Judy Wery. Excused Absence: Kay Hale. Several residents were also in attendance. Mayor Eldy Miller called the meeting to order at 7:00 pm and opened with the Pledge of Allegiance.

Correspondence: Council received minutes from the 6/21/2017 Planning and Zoning Meeting & several Resolution recommending the final plat for Creekside Estates & Deer Valley Third Addition, an amendment to the Zoning Code concerning Accessory Buildings, and a Good Neighbor Meeting Policy; Board of Adjustment minutes from 06/13/2017 meeting; Park & Recreation Board minutes from 06/28/2017; Deputy Todd Egli,

Linn County Sheriff Office, presented a report dated 6/12 to 7/10, 2017; Library minutes & monthly report from Director Sarah Sellon; a report from Ron Stark, Public Works. Callie O'Brien, newly hired Park & Recreation Coordinator introduced herself to council and shared of few of the ideas she has for future events in Ely.

Citizen Requests: None

Business: Glen Meisner, MMS Consultants, was present filling in for Scott Pottorff' absence. Glen introduced a Professional Service Agreement for final design and bidding on the Main Street Sanitary Extension Project. Council member Mehmen moved, second by Rohner, to adopt **Resolution 2017-07.017** Accepting Engineering Contract with MMS Consultants for Design and Quote Services for Extending a Sewer Service Main on North Main Street. Ayes: Rohner, Wery, Mehmen, Billick.

Meisner also informed council that the water and sewer study and the update to city maps was in process and expected to be complete by the August meeting.

Council member Mehmen moved, second by Billick, to accept the Knoll Court and Ranmar Court Repaying Project and make final payment in the amount of \$9280.30. Ayes: Rohner, Wery, Mehmen, Billick.

The Release of the Bank Performance Agreement for the Buresh Development was tabled until we get confirmation from Scott Pottorff that the project is completed to specifications.

Council reviewed a letter dated July 6, 2017 from Scott Pottorff, MMS Consultants, recommending that council accept the public improvements for Creekside Estates. Council member Mehmen moved, second by Rohner, to adopt **Resolution 2017-07.018** "Approving the Final Plat for Creekside Estates Subdivision in the City of Ely, Linn County, Iowa". The motion instructs City Administrator Hoy to hold off on filing the final plat with the County Recorder until the following items on the punch list are complete. Ayes: Rohner, Wery, Mehmen, Billick.

- 1. Install beehive intake grates.
- 2. Provide a two-year maintenance bond for all public improvements
- 3. Provide notice of deed restrictions for lot 14-16 that a flood plain permit from the IDNR is required to construct any house of building on said lots.
- 4. Replace sections of sidewalk that have been broken and install ADA rams near intersection of Evelyn Drive.
- 5. Install erosion control and seed all disturbed area.

Council member Mehmen moved, second by Rohner, to accept a quote from LL Pelling for seal coat work on Walker Street from Traer to Dow's Street and from 1440 Walker Street to Rowley Street. Square Yard price is \$2.05 and Cold Mix patching is \$15.00 per ton. Ayes: Rohner, Wery, Mehmen, Billick.

Ordinance No. 256 "PROHIBITING SMOKING AND THE USE OF TOBACCO AND NICOTINE INSIDE PUBLICALLY OWNED BUILDS AND ASSOCIATED GROUNDS" was introduced. Council member Mehmen moved to accept the first reading, second by Billick. Ayes: Rohner, Wery, Mehmen, Billick.

Council member Wery moved, second by Mehmen, to waive the second and third reading requirements of **Ordinance No. 256** "PROHIBITING SMOKING AND THE USE OF TOBACCO AND NICOTINE INSIDE PUBLICALLY OWNED BUILDS AND ASSOCIATED GROUNDS". Ayes: Rohner, Wery, Mehmen, Billick.

Council member Mehmen moved, second by Wery, to adopt **Ordinance No. 256 "PROHIBITING SMOKING AND THE USE OF TOBACCO AND NICOTINE INSIDE PUBLICALLY OWNED BUILDS AND ASSOCIATED GROUNDS"** and cause it to be published. Ayes: Rohner, Wery, Mehmen, Billick.

Ordinance No. 257 "AMENDING TITLE VI PHYSICAL ENVIROMENT, CHAPTER 13 ZONING CODE" was introduced. Council discussed the changes being made, specifically the Accessory Building section. Resident Josh Baker, 1230 State Street, offered council his opinion regarding the ordinances changes. Council member Rohner moved, second by Mehmen, to table the ordinance until council had time to meet with the Planning & Zoning to gain a better understanding of the reasons for the changes. Ayes: Rohner, Wery, Mehmen, Billick.

Ordinance No. 258 "AMENDING THE TITLE VI PHYSICAL ENVIROMENT, CHAPTER 13 ZIINING CODE BY ADDITING A SECTION ENTILED ELY GOOD NEIGHBOR MEETING" was introduced. Council member Rohner, second by Wery, to accept the first reading of said ordinance. Ayes: Rohner, Wery, Mehmen, Billick.

Council member Mehmen moved, second by Billick, to waive the second and third reading of **Ordinance No. 258** "AMENDING THE TITLE VI PHYSICAL ENVIROMENT, CHAPTER 13 ZONING CODE BY ADDING A SECTION ENTILED ELY GOOD NEIGHBOR MEETING". Ayes: Rohner, Wery, Mehmen, Billick.

Council member Mehmen moved, second by Wery, to adopt **Ordinance No. "AMENDING THE TITLE VI PHYSICAL ENVIROMENT, CHAPTER 13 ZONING CODE BY ADDING A SECTION ENTILED ELY GOOD NEIGHBOR MEETING"**, and cause it to be published. Ayes: Rohner, Wery, Mehmen, Billick.

Council member Mehmen moved, second by Rohner, to adopt **Resolution No. 2017-07.016** Adding a Street Light to the end of the cul-de-sac on Knoll Court. Ayes: Rohner, Wery, Mehmen, Billick.

Council member Mehmen moved, second by Wery, to appoint Millhiser Smith as the city's worker's compensation agent. The firm already represents us for Liability Insurance and offers safety training classes in Cedar Rapids. City Administrator Hoy recommends the switch to stream line insurance needs. Ayes: Rohner, Wery, Mehmen, Billick.

City Administrator Hoy introduced council to the concept of allowing residents to use a second portable water meter to track outside water usage. Residents would hook the meter to an outside spigot, using a garden hose, to track all outside water usage. Then after the watering season, residents would call in the meter reading to City Hall to receive a one-time per year sewer credit for the water that ran through the meter. Council gave permission for Hoy to present a written policy for the August meeting.

Council member Mehmen moved, second by Billick, to set a public hearing on the re-zoning of the Buresh Estates. Ayes: 4.

With no further business evident, council moved to adjourned at 8:31 PM.
