**ORDINANCE #270**

**ESTABLISHING A STOP INTERSECTION**

**SECTION 1. AMEND CHAPTER 65.02 "STOP REQUIRED".**

Chapter 65.02 of the Ely City Code is hereby amended by the addition of the following:

16. Deborah Anne Lane. Vehicles traveling East on Deborah Anne Lane shall stop at Jappa Road

**SECTION 2. REPEALER CLAUSE.** Any ordinance, provision or part thereof, which differs or is inconsistent with this ordinance is hereby repealed, to the extent of said difference or inconsistency.

**SECTION 3. SEVERABILITY.** If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional by a court of competent jurisdiction, such adjudication shall not affect the validity of the ordinance , or any section, provision or part thereof not adjudged invalid or unconstitutional


**SECTION 4. EFFECTIVE DATE.** This ordinance shall be in effect from and after its final passage, approval, posting as required by law.
